# **Local Food and Wine Experience Terms and Conditions**

The nature of this package and the organisation involved means terms and conditions specific to the Local Food and Wine Experience (the package) apply to your booking in addition to Belle Bois's booking terms and conditions, or they override some of Belle Bois's booking terms and conditions.

Every effort will be taken to deliver this experience as described, however, uncontrollable variables such as weather, safety, seasonality, and other conditions which affect agricultural production and product availability may lead to adjustments or alterations in the program.

Each Local Food and Wine Experience will proceed with a minimum of 3 bookings for 2 people each.

The Local Food and Wine Experience inclusions for two people are:

- 2 nights accommodation at Belle Bois in a one bedroom suite
- Breakfast on 2 days
- A two-course dinner including wine on one night
- Canapes and a three-course dinner including wine on one night
- Lunch on one day
- Visits to four or more producer's properties exclusively accessible to the tour group
- A private Vignerons Experience at De Beaurepaire Wines for the tour group
- Transport to and from producer's properties on one day

### Not included is:

- Transport to and from Belle Bois
- Visa and passport fees
- Travel insurance
- Optional purchases, activities, and all personal expenses.

### **Payment**

50% of the value of the package will be paid as deposit to secure your booking. You will receive an email confirmation that your booking has been secured. The full payment for your booking must be paid no later than 15 days prior to the check-in date at Belle Bois. Visa or Mastercard can be used to secure your booking and can be used to complete your payment when it is due.

# **Cancellations**

In the event of a cancellation of your tour booking due to a force majeure event with consequences beyond the control of both parties you may be offered the opportunity to reschedule your booking or be offered a credit voucher. At our discretion, we may offer you a refund but we are not obliged to do so.

In the event of a cancellation of your tour booking by us, other than due to a force majeure event, prior to check-in you will receive a full refund.

If you cancel your booking more than 30 days prior to check-in you will be refunded your deposit minus a \$100 cancellation fee. A cancellation by you from 30 days to 15 days before check-in at Belle Bois will be refunded 50% of the deposit.

There will be no refunds on your cancellation of your booking in the 15 days before check-in at Belle Bois.

By booking, you agree to grant the promoter a perpetual, worldwide, non-exclusive, sublicensable, irrevocable, royalty-free license to use the images entered. ## Your obligations

Fully enclosed shoes must be worn during the tour.

No smoking or vaping is permitted at Belle Bois or during Local Food Experience activities.

Federal, State and Local government laws apply and will be adhered to including but not limited to: Responsible Service of Alcohol, healthcare directions, and seatbelt wearing. If you fail to abide by a law and a fine is incurred, the fine will be payable by you.

Please bring any matter you have a complaint about to our attention at the time in order that we can attempt to rectify the matter.

When you book the Local Food Experience package you are also bound by the terms and conditions of Through The Grapevine Tours, the farms, wineries, and other businesses involved in the package. You accept and agree that:

It is your responsibility to read or listen and understand the terms and conditions as and when provided to you;

On each property visited you are required to follow any verbal directions by the producers as their terms and conditions. These may include biosecurity requirements, direction on where you are allowed to go on the property, and risks to avoid.

Should any provision of these Terms be unlawful, void, or otherwise legally unenforceable, the rest of these Terms shall remain in force as though the unenforceable provision had not been a part of these Terms.
